Approval of "DOUGLAS DELABIE" Shower Panels with Mixers

Your letter ref. DY-L1307001 dated 15 July 2013 refers.

It is noted that the fittings described below have been accepted by the United Kingdom Water Regulations Advisory Scheme (WRAS) to have complied with the requirements of the United Kingdom Water Supply (Water Fittings) Regulations / Scottish Water Byelaws when correctly installed.

Details of Fittings: 'Sporting' range of shower panels with brass shower heads and NBR 'O' rings. The units are operated via a push button. The inlet incorporates a single check valve (suitable for backflow protection against fluid category 2). Maximum working pressure 5.0 bar. Maximum operating temperature 60°C.

Size: ½" BSP male inlet

Model:

- (1) Sporting 714700: Shower Panel satin chrome finish.
- (2) Sporting 714701: Shower Panel white epoxy finish.
- (3) Sporting 714700GR: Shower Panel with spray grid and satin chrome finish.

- (4) Sporting 714701GR: Shower Panel with spray grid and white epoxy finish.

Installation Requirements: R001, R040

In view of the acceptance by WRAS, I have no objection to the use of the said fittings in fresh water supply plumbing systems subject to full adherence to Waterworks installation requirements. In particular, you are required to draw your customers' attention to the following installation requirements –

“Installation shall comply with the ‘Installation Requirements & Notes’ of the WRAS’s approval letter concerned.”

“The cold water supply to the fittings shall be drawn from the same source that supplies the hot water apparatus so as to provide a balanced pressure and to obviate the risk of scalding in the event of a restriction or failure in the water supply.” AND


“The shower head to be connected to the mixer should not be placed in submerged conditions and should be securely fixed to the original position after use.”

A condition of this acceptance is that the fittings to be installed should be replicas of the samples certified by WRAS and no modification should be made to the fittings. This acceptance may be withdrawn at any time if the standard of the fittings installed fails to meet that of the approved samples or if the fittings are found to be unsuitable for use in fresh water supply plumbing systems.

For the use of the fitting in any project, the Acceptance Reference Number at the bottom of this letter must be quoted as a means of identification of acceptance of the fittings by this Authority.
